Shipping:

Shipping is processed daily through UPS and the U.S. Postal Service. Same day shipping is provided IF parts are in stock. Special Order items normally ship within 2 to 4 days. Standard shipping rates apply to continental U.S. only (Hawaii, Alaska and Puerto Rico customers are notified of exact shipping rates upon order confirmation). Heavy or oversized items are shipped truck freight and may be subject to a surcharge. Notification of increased charges will be made prior to shipping.

Cancelled Orders:

Many of the items we offer are "Special Order" items. As most of our Manufacturers and Suppliers charge a 20% restocking fee on cancelled orders or returns, it is necessary for us to pass this charge on to you if you cancel your order with us. A 20% RESTOCKING FEE will be charged on ALL cancelled or returned orders. There is a \$5 minimum RESTOCKING FEE on any order that has been placed with us and then cancelled or returned.

Returns:

Return Authorizations are required to be made by phone. All Returns must be accompanied by an RA number provided by our office and the original invoice. Notification must be made within 24 hours of any missing, damaged or defective items. Returned items MUST BE RECEIVED by us within 15 days of original invoice. All items returned must be suitable for resale and in the original packaging. All Returns are subject to the 20% RESTOCKING FEE. If the Return is due to an incorrect item being received, then full credit including shipping will be issued. In cases where a Return is allowed after the 15 day return period, a higher RESTOCKING FEE will apply. All return freight is the responsibility of the purchaser. **NO RETURNS WILL BE ACCEPTED ON ELECTRICAL ITEMS OR ANY ITEM WITH A COST OF LESS THAN \$5.**

Back Orders:

Notification of backordered items will be made via e-mail or phone. Orders will be shipped when received unless cancelled by you. No orders will be held for Back Ordered items.

Pricing Errors:

All prices on website, catalog or on order confirmation are subject to change without notice. Every attempt is made to contact you in the event a price has changed prior to shipping. We reserve the right to charge additional amounts due, including after an item has shipped or cancel the order at our discretion. We are not responsible for pricing errors on the website or invoices.
